

Lawndale Title I Parent Engagement Plan

PART I. General Expectations

Lawndale Elementary School agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required campus Title I Parent Engagement Plan meet the requirements of section 1118(b) of the ESEA, and include as a component, a school-parent compact consistent with section 1118(d) of the ESEA.
- The school will notify parents of the plan in an understandable and uniform format and, to the extent practicable, in a language the parents can understand. The plan will be made available to the local community and updated annually to meet the changing needs of parents and the school.

- C. that parents are encouraged to be actively engaged in their child's education and school;
- D. that parents are equal partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child; and

E. the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. Description of how Lawndale Elementary School will implement the required components of the campus Title I Parent Engagement Plan.

1. Lawndale Elementary School will take the following actions to involve parents in the joint development of its campus Parent Engagement Plan under section 1112 of the ESEA:
 - Establish the campus Parent Engagement Advisory Council adequately represented by parents of attending children, administrators and Title I personnel. Other council members may include community members and students.
 - Annually hold a meeting to review, discuss, and revise the school's Title I Parent Engagement Plan.
 - Parents will be invited to attend the Title I Parent Engagement Plan and Revision meeting through written invitations sent home with the students, text message sent from Lawndale Elementary, and phone calls to key parents.
2. Lawndale Elementary School will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - Hold committee meetings, composed of parents and school staff, to review the Campus Improvement Plan.
 - Participants will be recruited to volunteer through letters sent home, through the school messaging system including voice messages and text messages, and personal or phone contacts.
 - Provide Title I, Part A school staff support in enhancing their School Campus Improvement Plans.
 - Staff support trainings will take place during professional development.
 - Administer the Title I campus Parent Engagement Survey designed to identify the type of support, information, and resources that parents' need included in their Campus Improvement Plan and campus Parent Engagement Plan to better support their children's education and become more involved in their school.
3. Lawndale Elementary School will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in the Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend. These informative meetings may include, but are not limited to, the following:
 - Back to School Night
 - Table during registration
 - Monthly PI meetings
4. Lawndale Elementary School will, in a timely manner, provide parents of participating children information about Title I, Part A programs that includes a description and explanation of the

school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet:

- This information will be given to parents in the annual Title I Meeting at the beginning of school, through 6 week newsletters, and through parent conferences.

5. Lawndale Elementary School will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible. These may include, but are not limited to, the following:

- Monthly PI meetings
- Parent Advisory Committee Meetings
- Parent/Teacher conferences

6. Lawndale Elementary School will provide each parent an individualized student report regarding the performance of their child on the state assessment in at least math, language arts and reading by:

- Sending notes home
- Making information available to parents about accessing the information online.

7. Lawndale Elementary School will provide assistance to parents of children served by the school, as appropriate, on important topics. These may include, but are not limited to, the following:

- Reviewing and understanding the state's academic content standards.
- Reviewing and understanding the state's student academic achievement standards.
- Reviewing and understanding the state and local academic assessments including alternative assessments.
- The requirements of Title I, Part A.
- How to monitor their child's academic progress.
- How to work with educators.
- Other topics that received strong parent interest as reflected by the Title I school Parent Engagement Survey.

8. Lawndale Elementary School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parent engagement. These may include, but are not limited to, the following:

- Library Night/Literacy Night.
- Math Night.
- Science Night.
- Discovery Center Night.
- Skyward Parent Training.
- Parent engagement programs

9. Lawndale Elementary School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to

implement and coordinate parent programs and build ties between parents and schools. These efforts may include, but are not limited to, the following:

- Parents will meet with the school Parent Involvement Committee
- Parents included in campus planning
- Parents participate in district surveys

10. Lawndale Elementary School will, to the extent feasible and appropriate, coordinate and integrate TI parental engagement programs and activities with public preschool and other similar programs (e.g., Head Start, Parents as Teachers, etc.) that encourage and support parents in more fully participating in the education of their children. These efforts may include, but are not limited to, the following:

- Send a letter to incoming parents inviting them to the Lawndale campus
- Participate in head start transition activities and provide parents with information
- Hold a preschool orientation for new parents

11. Lawndale Elementary School will take the following actions to ensure that information related to the school, parent programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand. These may include, but are not limited to, the following:

- Lawndale will provide services upon request

PART III. Discretionary Components of the Lawndale Elementary School Title I Parent Engagement Plan

Lawndale Elementary School may provide discretionary activities that build parents' capacity for engagement in Title I schools and the school system to support their children's academic achievement; these may include, but are not limited to, the following:
